Additives Found in American Cigarettes http://www.iprc.indiana.edu/druginfo/additives.html

A 1998 document that lists "599 ingredients [that] have been identified in tobacco industry documents as being added to tobacco in the manufacturing of cigarettes by the five major American cigarette manufacturing companies. While some of these chemicals, such as sugars, vanilla extract, prune juice, and vinegar, are generally recognized as safe when used in food products, all produce numerous additional chemical compounds when burned."

Alcohol Problems and Solutions http://www2.potsdam.edu/alcohol-info/

Presents information about problems associated with alcohol consumption. Topics include alcohol facts and myths, links to state laws, advertising, youth issues (including minimum drinking ages throughout the world), drinking and driving, and health. Also includes a glossary covering beer, wine, and distilled spirits. Searchable.

Examines threats to ocean life from pollutants from industry, agriculture, and other sources. Attitudes About Homosexuality & Gay Marriage

A study, updated in December 2004, that presents a compilation of polling data back to the 1970s about the acceptance of homosexuality and gay marriage in the United States. Includes links to related material. From the American Enterprise Institute for Public Policy Research.

Offers current and archived news articles, commentary, a photo gallery, related links, and more. The focus is on California, but the site includes same-sex marriage news from other states. From the San Francisco Chronicle.

Provides information and tips about wise water use, especially with respect to landscaping. Includes a watering calculator and watering index to help set automatic sprinklers, a searchable or browsable gardening guide featuring images of gardens and information about native and heritage plants, and a list of local plant retailers. From a group of Southern California water agencies.

California Climate Change Portal http://www.climatechange.ca.gov

"Combines information [from state government agencies and commissions] on the impacts of climate change on California and the state's policies relating to global warming" Provides background information, policy

papers, reports, legislation, and other materials on California strategy related to global warming, greenhouse gas emissions, and climate change in the state. Maintained by the California Energy Commission.

California Office of Privacy Protection http://www.privacy.ca.gov

Contains fact sheets, announcements, and links to other publications on privacy issues. Some of the topics include identity theft, phishing, spyware, financial privacy, privacy policies, health information privacy, and credit reports. Provides text of state privacy laws and pending and recently enacted California legislation.

California Solutions for Global Warming http://www.solutionsforglobalwarming.com/

Features background about a package of bills signed into law in September 2006 designed "to reduce California's emissions of carbon dioxide and other heat-trapping pollution," reports about global warming and clean energy solutions, links to news, and more. In English and Spanish.

Capital Punishment: All Points of View on the Death Penalty http://www.religioustolerance.org/execute.htm "Deals with the execution of criminals found guilty of having committed serious crimes." Features data, a description of methods, material about the status of the death penalty worldwide, and links to related sites.

Celebrate Your Freedom to Read: Explore Banned Books http://books.google.com/googlebooks/banned/ Lists 42 books that have been challenged or banned in the U.S. Includes links to catalog records for the books and to citations for books about the banned books for titles such as "To Kill a Mockingbird," "Lolita," "The Great Gatsby," "1984," "Catcher in the Rye," "Satanic Verses," and "The Color Purple." A collection of research and educational resources on child labor that features a database of legislation from around the world (searchable by country or topic) and annotated links to web resources.

Climate Group http://www.theclimategroup.org

"Features interviews with international business and government leaders, case studies about actions being taken by governmental and corporate actors "to minimize their carbon footprints," and suggestions for individuals for reducing emissions (with links to related sites). Also includes links to news stories, online publications, and more.

Commentary Today http://www.commentarytoday.com

"Devoted to presenting the most diverse and comprehensive collection of opinions and commentary from America's leading columnists. ... Every day this site is updated with the most recent articles" from dozens of political columnists. Browsable by political viewpoint ("on the left" and "on the right"). Also includes discussion boards relating to the articles.

Commercial Closet http://www.commercialcloset.org/

Examples from decades of commercials and advertising "that reflect society's changing view of the gay community with marketers' best and worst efforts from around the world." Includes images, stills, video clips, transcripts, commentary, and an online feature article section, "The Report."

Condoms: History, Testing, Effectiveness & Availability http://www.avert.org/condoms.htm

A timeline of the development of condoms from ancient Egyptian use of "a linen sheath for protection against disease" through the 1800s, when "condom manufacturing was revolutionised by the discovery of rubber vulcanisation by Goodyear (founder of the tyre company) and Hancock," and the present day. Also includes a link to information about the female condom. From Avert, "an international HIV and AIDS charity based in the UK."

DEA: Drug Information http://www.dea.gov/concern/concern.htm

Fast facts and news about illegal drugs and drugs that are abused in the U.S. From the U.S. Drug Enforcement Administration (DEA).

Death Penalty Information Center (DPIC) http://www.deathpenaltyinfo.org/

Includes a database of all executions since 1976, searchable by name, year, age, race, gender, location, method of execution, and special factors. Also provides reports on issues such as innocence, juveniles, mental illness, and costs, as well as facts about death row, sentencing, data for individual states, and the history of the death penalty. Portions of the site also available in Spanish.

Dietary Supplements: Ephedrine Alkaloids http://www.cfsan.fda.gov/~dms/ds-ephed.html

Official U.S. Food and Drug Administration (FDA) information regarding the regulation of dietary supplements containing ephedrine alkaloids (commonly known as ephedra). Includes questions and answers about the FDA's 2004 decision to ban the sale of the supplements, the text of proposed and final regulations related to ephedra, and related transcripts and documents.

Provides information about drowsy driving and "falling asleep at the wheel," including danger signals, a drowsy driving quiz, audio clips, and input from drivers who have been in crashes related to drowsy driving. From the AAA (American Automobile Association) Foundation for Traffic Safety.

Drug Policy Alliance: Marijuana: The Facts http://www.drugpolicy.org/marijuana/

Features an overview of and legal challenges to medical marijuana laws in the U.S. (including California's Proposition 215), highlights from the book "Marijuana Myths, Marijuana Facts, and related information. From a group that "is working hard state by state to educate lawmakers about marijuana and to make cannabis available for medicinal purposes for seriously ill people."

Ecolex: A Gateway to Environmental Law http://www.ecolex.org/

A searchable, global database on environmental law. Includes bibliographic information for treaties, national legislation, court decisions, and literature from international journals and monographs. Links are made to full text if available. Also in French and Spanish. From the Food and Agriculture Organization (FAO) of the United Nations, the World Conservation Union (IUCN), and the United Nations Environment Programme (UNEP).

Electronic Surveillance Laws http://www.ncsl.org/programs/lis/CIP/surveillance.htm

Summary of state and federal laws for electronic surveillance, which "involves the traditional laws on wiretapping -- any interception of a telephone transmission by accessing the telephone signal itself -- and eavesdropping -- listening in on conversations without the consent of the parties." Features a chart showing state laws, and descriptions of the Wire and Electronic Communications Interception and Interception of Oral Communications Act, USA PATRIOT Act, and other federal laws.

End-of-Life Choices: Feeding Tubes and Ventilators

A fact sheet that discusses two common decisions facing families of chronically ill people: using feeding tubes when the person cannot swallow, and ventilators when the person cannot breathe on his or her own. Covers petroleum, natural gas, electricity, coal, nuclear, and renewable and alternative fuels. Provides forcasts and analyses; state and U.S. historical data overview; information on households, buildings, and industry; and environmental data. Includes both U.S. and international data.

Equal Marriage for Same Sex Couples http://www.samesexmarriage.ca/

Information about the "issue of full and equal marriage for gays and lesbians" primarily in Canada. Documents a Canadian couple seeking legal recognition of their right, as a same-sex couple, to marry. Includes news and law summaries, information about registered domestic partnerships (RDPs), a Canadian marriage timeline, and links to news, media coverage, information on court decisions, and more.

Failure of Initiative: The Final Report of the Select Bipartisan Committee to Investigate the Preparation for and Response to Hurricane Katrina http://katrina.house.gov

This February 2006 report is based on a House investigation that included statements from individuals such as the governors of Louisiana and Mississippi, the mayor of New Orleans, Michael Chertoff (secretary of the Department of Homeland Security), members of the Federal Emergency Management Agency (FEMA), and New Orleans citizens and evacuees. From a committee of the House of Representatives.

Fast Food and Animal Rights: McDonald's New Farm

Health Consequences of Smoking: A Report of the Surgeon General

Includes links to related government resources on smoking.

A companion to the 2006 documentary about global warming. Features suggestions for individuals to reduce harmful emissions at home and traveling and to advocate for changes locally, nationally, and internationally. Also includes an interactive tool to calculate your personal impact, 10 simple tips to reduce your impact, and links to related materials. Also includes links to details about the documentary.

Provides an overview of "Indian gambling on tribal land [which] has become a significant political issue in California." Discusses legislation and cases related to sovereignty, Native Americans and taxation, tribal gaming. Also has a section on California Governor Arnold Schwarzenegger and Indian gaming. Includes related books, articles, and Web sites.

Contains many different areas. "Research and Publications" provides access to research articles, publications (books), and recommended sources on terrorism. "Articles" and "News and Commentaries" provide information on current issues involving terrorism. "Spotlight" highlights a particular topic. Prior Spotlight articles can be located by typing "spotlight" into the search bar on the homepage. Other links include "News" (current news on terrorism-related items), "Featured Publication," and "ICT in the Media" (articles, interviews, etc. involving ICT).

swordfish, and tuna. Discusses the risks to pregnant and breast-feeding women. From the British Food Standards Agency.

Methyl Tertiary Butyl Ether (MTBE) http://www.epa.gov/mtbe/

Resources on MTBE, a chemical compound that is "almost exclusively used as a fuel additive in motor gasoline." Features documents on the use of MTBE in gasoline, effects of MTBE on the water supply, research and testing of potential health and environmental risks, preventing MTBE leaks from underground storage tanks, and cleanup and treatment actions. Includes local contacts for information about MTBE in drinking water. From the U.S. Environmental Protection Agency (EPA).

Mifeprex (Mifepristone) Information http://www.fda.gov/cder/drug/infopage/mifepristone/

Background information about the drug mifepristone ("trade name Mifeprex, also known as RU-486"), which was approved by the U.S. Food and Drug Administration (FDA) in 2000 "for the termination of early pregnancy, defined as 49 days or less." Provides guidelines for use, label information, official documents, and other consumer information. Also includes details about the FDA's November 2004 statement about "safety changes to the Danco Laboratories, LLC's labeling of mifepristone." From the FDA.

MIPT Terrorism Knowledge Base http://www.tkb.org/

Covers "research and analysis on global terrorist incidents, terrorism-related court cases, and terrorist groups and leaders. ... The database features interactive maps, biographies on key terrorist personalities," and creates "charts and graphs and tables that analyze RAND data on terrorist incidents or legal data on the prosecution of terrorists."

National Association for Single Sex Public Education (NASSPE) http://www.singlesexschools.org/

Presents information supporting this organization's advocacy of single gender education, including discussions of sex differences in the brain and how children learn and the benefits of one-sex schools for girls and boys. Also includes a list of single sex public schools in the United States and links to related information.

National Immigration Law Center (NILC) http://www.nilc.org

Provides issue briefs, articles, and other material about "immigration, public benefits, and employment laws affecting immigrants and refugees" as well as analysis of pending immigration reform legislation, which includes topics such as guest workers, driver's licenses, and border controls. Other features include links to related federal and California sites and information for Hurricane Katrina survivors. From an organization "dedicated to protecting and promoting the rights of low income immigrants and their family members."

National Indian Gaming Association http://www.indiangaming.org

Features a history of Indian gaming, Indian gaming facts, an overview of current legislative issues, and documents related to Indian gaming. Searchable.

National Sex Offender Public Registry http://www.nsopr.gov

A search tool allowing a user to submit a single national query to obtain information about sex offenders through a number of search options" combined with state(s), including name, ZIP code, and location. Searches include more than 20 states and Washington, D.C.

Native American Mascots: An Examination http://www.tolerance.org/news/article_tol.jsp?id=168

A 2001 article discussing Native American mascots for sports teams. Topics include what a mascot is, "The Stereotype of the Noble Savage," and "The Stereotype of the Demonic Indian." Also includes links to related sites.

Nature and Scope of the Problem of Sexual Abuse of Minors by Catholic Priests and Deacons in the United States http://www.usccb.org/nrb/johnjaystudy/

February 2004 report includes sections on the prevalence of abuse of youth under 18 by Catholic priests and deacons, information about the accused priests and deacons and about the incidents and allegations, and the response from the diocese and religious communities.

Note: in 2005, this report became Country Reports on Terrorism, fulfulling the mandate but without the statistical section.

Provides links to general LGBT history pages, collections of textual material, museums and archives, and lesbian-specific sites.

Background information and supporting documents for the U.S. Supreme Court case on the constitutionality of a public school district policy that requires teachers to lead willing students in reciting the Pledge of Allegiance, which includes the words 'under God.'" Provides links to the briefs and related articles and editorials.
